Dr. Sandra L. Alzate is associate professor of Spanish at Muskingum University. She received her Ph.D. in Spanish from the University of Cincinnati in 2008. Her research focuses on twentieth-century women and Afro-Colombian authors with a particular interest in the works of Manuel Zapata Olivella. Dr. Alzate's articles have been published in peer-reviewed journals such as *Hipertexto* and *The Afro-Hispanic Review*.

Dr. William O. Deaver, Jr. is professor of Spanish at Armstrong State University. He holds a Ph.D. in Spanish from Florida State University. His research focuses on authors from Spain, Latin America, and on Hispanic authors of the U.S. In addition to book chapters, his numerous articles have appeared in peer-reviewed journals such as *Alba de América*, *Confluencia*, *Crítica hispánica*, *Hispanófila*, *Monographic Review*, *Neophilologus*, *Revista de estudios hispánicos*, *Romance Languages Annual*, *Romance Notes*, *The Coastal Review*, and *Theory in Action*.

Dr. Matthieu P. Raillard is associate professor of Hispanic studies at Lewis & Clark College in Portland, Oregon. He received his Ph.D. from the University of Virginia in 2004. He specializes in Spanish literature of the eighteenth and early nineteenth centuries. His research interests include authorship and narrative authority, the literary marketplace in eighteenth-century Spain, Franco-Spanish relations, and Spanish Romanticism. Dr. Raillard has published in a number of well-known peer-reviewed journals, including *Decimonónica*, *Dieciocho*, *Revista de estudios hispánicos*, and *Studies in Eighteenth-Century Culture*.

Dr. Jorge L. Rosario-Vélez is professor of Spanish at Long Island University—Post. He received his Ph.D. from Stony Brook University. His research focuses on popular culture and bolero in narrative literature of the Caribbean as well as topics of gender and nation in women's poetry of Spanish America. His studies on Caribbean and peninsular literature have appeared in peer-reviewed journals such as *Ciberletras*, *Hispanic Research Journal*, *Hispanófila*, *Latin American Literary Review*, *Letras femeninas*, *Revista de estudios hispánicos*, *Revista iberoamericana*, and *Romance Languages Annual*.

Dr. James A. Wojtaszek is associate professor of Spanish at the University of Minnesota in Morris. He received his Ph.D. in Spanish from Rutgers University in 2000. Dr. Wojtaszek specializes in nineteenth-century Spanish literature and culture. His past scholarship has included work on writers of the Generation of 1898, the poets Rosalía de Castro and Gustavo Adolfo Bécquer, and the anarchist writer Soledad Gustavo. His current scholarship focuses on nineteenth-century women writers, such as Carolina Coronado and Filomena Dato Muruais, and includes grant-funded research on the Galician Revival, both in Spain and Argentina, with particular emphasis on the role of women in the movement.
